I understand that all items will be sold on an online auction to the highest bidder. Reserves on any item will need to be made in writing on this consignment contract, accompanied by a reserve fee per item payable at the time of consignment. The reserve fee is determined based on the specified reserve price. If reserve is met, the reserve fee will be applied to that item at part of the commission. Consignor agrees not to bid on their own items (Buybacks are NOT ALLOWED.)

Consignor understands that all items sold at auction will be subject to a buyer's premium which is decided at the time of consignment by Iggy's Auction House LLC. The buyer's premium will be retained by the auctioneer.
